Compensation and Benefits

CBRE offers a comprehensive, market-competitive benefits package designed to provide the coverage and security that fits your and your family's unique needs.

Full-time employees in the U.S. are eligible to participate in the following CBRE Benefits*:

- Medical, Dental and Vision coverage through national carriers.
- Basic Life at 1.5x base salary, no cost. Optional Supplemental Life and Accidental Death & Dismemberment.
- Short and Long-Term Disability Insurance is company-provided. Optional Buy-Up LTD.
- 401(k) employer match on up to 6% of your own contribution, fully vested at 5 years.
- Health Savings Account with employer contribution or Flexible Spending Account.
- Employee Assistance Program, Mental Well-being and Behavioral Health coverage.
- Paid Time Off accrues for 15 to 28 days each year for sick, vacation and personal time off, with rollover, based on years of service.
- The Highly Compensated Employee PTO program provides salary continuation for qualifying employees, in lieu of traditional PTO.
- Paid Company Holidays total 11 days annually.

* Union Employees are not eligible for CBRE's benefits. Employees classified as "commissioned" and "independent contractors" are not eligible for certain benefits, including paid vacation and paid company holidays. Other restrictions apply based on employee classification.
