WM annually invests \$10,000+ per employee in comprehensive benefits

WM pays the full cost to provide employees with short-term and long-term disability benefits, basic life and AD&D insurance for employees and their eligible dependents, legal services and critical illness coverage for employees, and an employee and family assistance program. The cost for optional coverages like medical and dental are shared with employees, with WM picking up a majority of the expense.
